Winding-up (WU) – notification has been filed at Companies House to wind up the company as a result of a petition.
Meeting of creditors (MOC) – notification that a meeting is to take place considering action to wind up the company.
Petitions winding-up (PWU) – a notice of a court hearing to consider action for the compulsory winding-up of a company.
Receivership document lodged (RDL) – this means that a receiver has been appointed.
Appointment of Liquidator (AOL) – A liquidator is appointed to wind up a company's affairs. He calls in all the company's assets and distributes them to its creditors. If anything is left over, the liquidator distributes it among members of the company.
